VKP Partners Oleg Makarov and Denys Lysenko participating in the Third CIS Local Counsel Forum held in St. Petersburg (Russia)

This year the Forum, being the most significant gathering of law practitioners from the former Soviet Union territories, was held in Russia for the very first time. Delegates from the largest CIS law firms and international law community met in warm and friendly atmosphere to share experience and communicate new economic and legislative trends from their countries as well as to look into prospects of joint activities and long-term cooperation.

On the first day of the Forum Mr. Oleg Makarov, the Managing Partner with Vasil Kisil & Partners, took part in the round table discussion dedicated to organizational and managerial issues of the law practice, such as interrelations between the partners, marketing advancements, attracting new talents, upgrading competences, billing procedures, implementing cutting-edge technologies, legal and attorney fees, development programs, etc.

Second-day morning sessions highlighted a general situation and recent news from the law practice in the participating states, including Ukraine.
