ABOUT THE CONFERENCE

We cordially invite you to the Russian-Polish Legal Day, which will take place on 21 November 2012 at the Warsaw Stock Exchange.

The idea for this undertaking arose during preparation of the European Forum of the International Bar Association conference called *Opportunities and Challenges that growing businesses face in selected new EU member states - perspectives for the future*, which will take place on 22-23 November 2012.

In the past, several similar conferences in Poland as in other European countries were accompanied by more informal sessions during which lawyers from two selected countries were able to become better acquainted with each other and share their experiences.

The main subjects for discussion during the Russian-Polish Legal Day are:

- capital markets: challenges of conducting business by Russian companies in Poland and Polish companies in Russia
