## Mid-Size Law Firms are Better Adaptable to Rapid Changes

*This is a full version of the Article, which was published in a short version in Ukrainian language in the year-end issue of one of the leading legal newspapers of Ukraine – "Yurydychna Gazeta" on 20 December 2011.*

In general, we may say that current tendencies in legal market amid the economic crisis stimulate law firms to constant development, strengthening of relations with clients, serious work on internal reforms and improvement of the efficiency of work along with strict control over costs, as well as more careful hiring policies, giving preference to universal lawyers as opposed to lawyers with narrow specialization because rendering of effective and timely legal services can be only based on high professional skills and broad experience. As we see it, mid-size firms (15-25 experienced lawyers) are the most adaptable to rapid changes, in particular those related to crisis in current Ukrainian economy. We also prefer to hire lawyers with at least 7-year professional experience, and we note that despite the seeming availability of legal professionals on the labor market, it is still difficult to find a senior counsel with extensive universal experience.

Our team began its legal practice in the Ukrainian market almost 20 years ago. During this period we have gone through various economic and political circumstances with our clients, entered the global market, promptly responded to new tendencies in the legal practice, developed our practice areas, made constant investments into our major intellectual asset –

highly skilled lawyers - and we may proudly say that we have been a reliable and competent partner to our clients throughout the entire period of our existence.

Despite the ongoing economic crisis, summarizing the results of 2011 we are pleased that in many ways it was successful for our company.
